**Subject: Update on Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

We refer to our intimation dated January 12, 2026, wherein the Company had informed the stock exchanges regarding intimation received from its tax advisors and e-mail communications from the Customs, Excise & Service Tax Appellate Tribunal (CESTAT), Mumbai stating that the appeals filed by the Company against demand raised aggregating to ₹ 1,095.68 Million (including penalty) for FY2008-09 to FY2011-12, FY2013-14 & FY2014-15 and ₹ 1,186.88 Million (including penalty) for FY2011-12, had been allowed and copies of the appeal orders were awaited.

In this regard, we wish to inform that the Company has received copies of all appeal orders from the CESTAT, the latest being received on June 9, 2026, at 3:55 p.m., confirming that the appeals filed have been allowed in favour of the company. 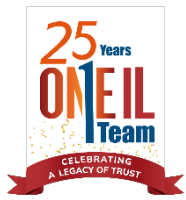

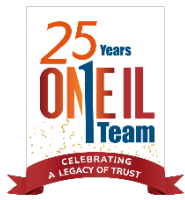
