Rekha, Sachdeva hold public outreach programme

Addressing the gathering, Chief Minister Rekha Gupta said that during the rule of the Congress and the Aam Aadmi Party, people had never heard of 100 crore worth of work being carried out in every Assembly constituency. "Today, at least 100 crore worth of work is being executed in each constituency," she said. The Chief Minister stressed that her Government considers power a medium of service, not returned. She said the BJP returned to power in Delhi after 27 years of struggle and cannot afford to waste time. "We have to fulfil the expectations with which the people have blessed us," she said. She added that as a 'triple-engine Government', there is no competition for taking credit for development work. Whether funds are allocated to MPs, MLAs or municipal councillors, the results will reach citizens, she said. The Chief Minister listed major focus areas over the past 365 days, including sewer systems, pipelines, Yamuna cleaning, pollution control, roads and transport infrastructure. She said work is underway on 40-foot overbridges and several flyovers and promised visible transformation every year. The Chief Minister informed that nine Atal Canteens have been established in the New Delhi Lok Sabha constituency. The ongoing infrastructure development projects worth approximately 135 crore are underway in the Moti Nagar Assembly constituency, including the construction of a foot overbridge at Kirti Nagar and a bridge over the Najafgarh drain. In the Rajendra Nagar constituency, development works worth nearly 100 crore are progressing at a rapid pace. Delhi BJP President Virendra Sachdeva said the BJP releases a "Sankalp Patra"

and not merely a manifesto during elections. He claimed that several commitments made to the public have already been fulfilled and the groundwork for others has been laid. "For a developed India, a developed Delhi is essential. Delhi is moving steadily on the path of development," he said. He added that it is the party's duty to inform every household about the Government's work. New Delhi MP Bansuri Swaraj said there is renewed enthusiasm among citizens since the formation of the BJP Government. She announced that 12,000 crore was allocated for Delhi Jal Board works during a Tadaipur meeting. She also cited allocations of 10 crore for Rajendra Nagar Assembly and 128 crore for Malviya Nagar, and 100 crore each for Greater Kailash and RK Puram. Swaraj said 14 Atal Canteens have been opened in the New Delhi constituency, offering meals at 15. Other projects include multi-storey parking in GK-1, desilting of the Beasapahar drain, 400 Kusk Nala Bus Depot and the launch of the Dev Bus from Lodhi Colony. She also said 139 Chhat Ghat, including 10 model ghats, have been developed. The programme was coordinated by Delhi BJP President Virendra Sachdeva and attended by several ministers. The BJP said the outreach reflects a confident Government presenting its work directly to the people.

Police chief eyes making Delhi drug-free

The Delhi police chief has set his sights on making the national capital drug-free. With a special focus on curbing narcotics abuse in J clusters that are considered vulnerable to drug trafficking and consumption, an official said on Thursday. At the first crime review meeting of 2026 held in January, Police Commissioner Satish Golchha made it clear that eliminating the drug menace would be the top priority of the force for the year. Golchha has directed all deputy commissioners of police (DCPs) to submit detailed reports on J clusters aimed at eradicating the supply and consumption of narcotics in slums under their jurisdictions, a senior police officer said. "The commissioner has given clear instructions that we must not allow drugs to take the future of our youth. J clusters are particularly vulnerable and need focused intervention," the officer said. According to the

officer, DCPs have been asked to identify active drug dealers and peddlers operating in these areas and review their criminal status — whether they have been arrested, are on bail, or are absconding. Where legally feasible, steps such as extension proceedings and preventive detention under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances (PITNDPS) Act, 1988, are being examined. "The emphasis is not merely on arresting street-level peddlers. We have been told to dismantle the entire supply chain by working on both backward and forward linkages — from source to distribution network," the officer said. Police units have also been instructed to coordinate closely with specialised anti-narcotics teams and enhance surveillance in identified hotspots. Data analysis, informer networks and technical intelligence are being leveraged to track repeat offenders and interstate suppliers. In addition to enforcement measures, the commissioner has stressed the need for preventive outreach. Districts have been asked to organise awareness campaigns in J clusters, schools and community centres to sensitise teenagers and young adults about the harmful effects of drug abuse. "Our approach is two-pronged — strict action against traffickers and sustained community engagement to prevent addition. The ultimate goal is to make Delhi free of drugs," the officer added.

Speaker Gupta urges youth to lead India

Delhi Assembly Speaker Vijender Gupta on Thursday said that when students from Ladakh and other parts of the country visit democratic institutions, they strengthen the living bond of national unity. He was addressing an interactive session with a delegation of students from the Union Territory of Ladakh and other regions at the Assembly complex. The visit was organised by the Akhil Bharatiya Vidyarthi Parishad (ABVP) under the Students' Experience in Regional Understanding (SERU) initiative. Gupta said such exchanges go beyond geography and help build a confident and integrated India. He told the students that their visit was not merely ceremonial. It was an opportunity to witness how a democratic system functions through dialogue, accountability and public service. "Within these walls, policies are shaped and public

concerns are raised in accordance with the Constitution," he said. The speaker said India is at a pivotal moment in its journey toward becoming a developed nation by 2047. He described Viksit Bharat as a vision that goes beyond economic growth. It includes social inclusion, quality education and technological progress. "The path to Viksit Bharat runs through the minds and hearts of young citizens like you," he told the students. He urged them to uphold integrity, innovation and unity. Referring to the guiding philosophy of the programme, "Aam Deepo Bhav" (Be your own light), Gupta encouraged students to develop culture of thought and self-confidence. Speaking on the occasion,

Sood inaugurates Student Facility Centre at Maharaja Agrasen College

Delhi's Education and Higher Education Minister, Ashish Sood, on Thursday inaugurated the newly constructed Student Facility Centre and laid the foundation stone for the Indian Knowledge Tradition Centre and sports facility at Maharaja Agrasen College, Gurgaon. He also dedicated a multimedia seminar hall and five smart classrooms and launched an RFID-enabled library management system in the college library. The programme was presided over by Prof. (Retd.) Balraj Pani, Dean of Colleges, University of Delhi. A delegation of 12 principals of University of Delhi colleges, fully funded by the Government of Delhi, was also present at the function today to felicitate the ministers for realising their long-pending wishes. It may be recalled that for the past 10 years, these colleges had been deprived of government grants, totally disrupting the educational environment in these colleges. Speaking on the occasion,

Sood said the Government is working to strengthen higher education through improved infrastructure and technology and aims to drive a long-term overhaul of the Capital's education system. He said the new student facility centre would provide a more supportive academic environment, while the Indian Knowledge Tradition Centre is expected to promote research into Indian knowledge systems, culture and traditions. Assuring teachers and institutions, Sood said no college would face a funds crunch and no teacher's dignity would be compromised. "The Government is working with 'scale and speed' to expand smart infrastructure, including a plan to convert 7,000 classrooms for Classes 9 to 12 into smart classrooms in the next phase," Sood said. According to the statement, these colleges had faced a complete halt in Government grants for nearly a decade, which had disrupted their functioning. The minister said the Government's broader aim is to position Delhi as a knowledge capital by 2047, when India marks 100 years of independence, stressing that the focus would be on strengthening systems across schools, colleges, technical institutes and research centres.
