This is to inform that Care Health Insurance Limited (CHIL), a material subsidiary of Religare Enterprise Limited (“the Company”) has received a Show Cause Notice (“SCN”) dated March 02, 2026 from Insurance Regulatory Development Authority of India (“IRDAI”) with respect to thematic onsite inspection of the Company conducted during the period from 10.02.2025 to 14.02.2025. IRDAI had issued its observations on the inspection, which was earlier replied by CHIL.

CHIL is in the process of taking remedial/ appropriate steps in the matter as advised and preparing its reply to the Show-cause notice.
