Yogi will lead BJP in 2027 UP polls: Tawde

BJP national general secretary Vinod Tawde has affirmed that Chief Minister Yogi Adityanath will remain the party's face for the 2027 Uttar Pradesh Assembly elections, predicting a third consecutive victory for the NDA. Making his first visit to the state after taking charge, Tawde aimed to settle internal leadership speculation and signal the start of early electoral preparations.

During organisational meetings at the party headquarters alongside co-incharge Jagdeep Bhai Patel, Tawde met state BJP president Pankaj Chaudhary and general secretary Dharampal Singh to devise an action plan. Internal discussions highlighted that the BJP should counter the Samajwadi Party's PDA formulation not through

caste arithmetic, but by showcasing developmental achievements benefiting farmers, women, youth, and the underprivileged.

Leaders recommended mobilising active workers at the grassroots level long before voting begins.

Tawde noted that the cen-

tral leadership attaches significant weight to Uttar Pradesh and is actively tracking political shifts. He also launched a direct political strike on SP chief Akhilesh Yadav, redefining the opposition's PDA acronym to mean "paraya dhan apna", or treating another's wealth as one's

own. Tawde asserted that NDA workers would dismantle the SP's narrative, noting that the party aims to both secure victory and govern effectively for the subsequent five years.

Tawde stressed that the pace of governance under Yogi had accelerated, offering a clear track record for workers to bring to voters. As the BJP kicks off its organisational campaign more than a year in advance, the political landscape in Uttar Pradesh is setting up a direct battle between developmental governance and opposition social alliances.

NCSC issues notice to Keralam over attack on Cong MLA Haridas

The National Commission for Scheduled Castes (NCSC) on Sunday issued a notice to the Keralam chief secretary and DGP, seeking an action-taken report on an alleged attack involving Congress MLA Ramya Haridas.

The notice follows a report claiming that party leaders attacked Haridas in Thiruvananthapuram district's Chirayinkeezhu.

The NCSC has taken suo motu cognisance of the matter and directed the state authorities to submit a detailed action-taken report within seven days of receiving the notice. The commission has sought details including the FIR number and sections invoked, names of the accused, arrests made, chargesheet or final report and details of compensation paid to the victim.

The notice said that if the

Commission does not receive the report within the stipulated time, it may exercise its powers under Article 338 of the Constitution and issue summons for appearance before it by the authorities or their representatives.

The NCSC notice referred to the allegation under the caption, "Kerala Congress MLA Ramya Haridas Alleges Attack By Party Leaders".

Haridas has alleged that she was attacked and threatened by local Congress leaders, while district panchayat member Sajith Muttambalam and party leader Sajad have alleged that the MLA and her associates had confronted them over a WhatsApp post, following which a scuffle broke out.

Haridas, a Dalit woman face of Congress in Keralam, allegedly sustained injuries in the incident on Friday night and sought treatment at the Chirayinkeezhu taluk hospital.

Modi's Instagram comment provocative, says CPI(ML)

Communist Party of India (Marxist-Leninist) General Secretary Dipankar Bhattacharya on Sunday alleged that Prime Minister Narendra Modi's remark on Instagram regarding young women using "crude and abusive" language during student protests at Jantar Mantar was "provocative".

Speaking at the "Gen-Z Rising" programme, Bhattacharya stated that the Prime Minister's online comments encouraged forces involved in intimidation and violence.

He claimed the repercussions were visible on social media and on the ground, citing youth activists who faced harassment following the remarks.

The event was organised by the AISA-Revolutionary Youth Association. Bhattacharya further criticised the targeting of young activists on August 15 under the label "Dimagi Naxal", calling it part of a deliberate politics of provocation. He asserted that youthful questions cannot be silenced

through repression or defamation.

Linking political violence in Bengal to the Prime Minister's rhetoric, Bhattacharya claimed the "vibrant Civil Defence network" mentioned in Modi's August 15 Red Fort speech consisted of goons who assault citizens. He demanded that legal cases against Jantar Mantar protesters and farmers be withdrawn.

All India Students' Association General Secretary Neha thanked the people of Bihar for backing the Jantar Mantar movement. She insisted that CM Samrat Choudhary answer for widespread irregularities in the Bihar Public Service Commission 70th examination and police recruitment tests.

Neha stated that the student movement exposed the government's repressive character.
