Gist of proceedings of the 40th Annual General Meeting of Chartered Capital and Investment Limited

A. Date, Time and Venue of the Annual General Meeting (Meeting):

The 40th Annual General Meeting of the Company was held on Thursday, September 17, 2026 through Video Conferencing (VC) / Other Audio-Visual Means (OAVM). The Meeting commenced at 11:30 a.m. (IST) and concluded at 11: 39 a.m. (IST).

B. Proceedings in brief:

Mr. Mohib N. Khericha, Managing Director of the company, as unanimously elected by the Board, chaired the Meeting.

The requisite quorum being present, the Company Secretary with the consent of Chairman called the Meeting to order.

The Company Secretary informed that the Meeting was held through VC / OAVM in compliance with the circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India. The Company had also provided live webcast of the proceedings of Meeting.

The Company Secretary informed that remote e-voting commenced at 9:00 a.m. (IST) on Monday, September 14, 2026 and concluded at 5:00 p.m. (IST) on Wednesday, September 16, 2026.

The following items of business as set out in the Notice convening the 39th Annual General Meeting were commended for members' consideration and approval:

Ordinary Business

1. Adoption and Consideration of the audited Balance Sheet as on March 31, 2026 and the Profit and Loss Account for the year ended on that date and the reports of the Board of Directors and Auditors thereon which is an Ordinary Resolution.
2. Appointment of Mr. Mohib N Khericha, a Director retiring by rotation which is an Ordinary Resolution.

Special Business

3. Re-appointment of Mr. Mohib N Khericha (DIN: 00010365) as a Managing Director of the Company and approve the payment of remuneration to him

for a period of 3 years and in this regard to consider and, if thought fit, to pass, with or without modification(s) which is a **Special Resolution**.

The Company Secretary also informed the members that Mr. D.A. Rupawala, Proprietor D. A. Rupawala & Associates, Practicing Chartered Accountants, was appointed as the scrutiniser to scrutinise the voting through electronic means (i.e. remote e-voting and voting at the meeting by using electronic system).

The Company Secretary also informed the members that the results of e-voting shall be disseminated to the stock exchange and also uploaded on the website of the Company and NSDL the authorized agency provided e-voting facility.

C. Voting by Members:

The Company had provided remote e-voting facility to its members to cast votes electronically on all 3 items of business set out in the Notice.

Further, the facility to vote on resolutions through electronic voting system at the meeting was made available to the members who participated in the meeting and had not cast their votes through remote e-voting.
