Dear Sir / Madam,

This is with reference to our letter dated April 30, 2026, wherein we had informed that the operations of the manufacturing plant situated at Unit: Kadiyam were disrupted due to an illegal strike by contract workmen with effect from April 27, 2026.

Since the commencement of the said illegal strike, the Management has made repeated appeals to call off the illegal strike to resume duties and restore normalcy. However, these appeals have been disregarded. The strike is leading to loss of production.

In view of the prevailing situation, and in order to safeguard the employees, plant and machinery, materials, and other assets, the Management has declared a lockout at the Kadiyam Unit with effect from 10:00 PM on May 1, 2026. The lockout shall remain in force until further notice.

The details as required under Regulation 30 of SEBI (LODR) Regulations read with SEBI circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026 is enclosed as Annexure A.
