Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Schedule III thereto, and in continuation of the Company's earlier intimations dated 10 February 2026, 28 February 2026 and 24 June 2026, we wish to inform you that the withdrawal of the Company's remaining partnership interest in Shri Bajrang Chemical Distillery LLP ("SBCD LLP") has been completed.

The transaction was undertaken pursuant to the approvals granted by the Audit Committee and the Board of Directors of the Company at their respective meetings held on 24 June 2026. Thereafter, the Partners of SBCD LLP, at their meeting held on 26 June 2026, approved the withdrawal of Shri Bajrang Alliance Limited from the LLP and a Fresh LLP Agreement was executed amongst the continuing Partners on the same date.

Accordingly, with effect from 26 June 2026, Shri Bajrang Alliance Limited has ceased to be a Partner of SBCD LLP and no longer holds any partnership interest therein.

The disclosure required under Regulation 30 of the SEBI (LODR) Regulations, 2015 is enclosed as **Annexure–A**. A confirmation letter received from SBCD LLP regarding completion of the withdrawal and reconstitution process is also enclosed.

This has reference to your letter dated 24 June 2026 conveying the proposal approved by the Board of Directors of Shri Bajrang Alliance Limited (“SBAL”) for withdrawal of its remaining partnership interest in Shri Bajrang Chemical Distillery LLP (“LLP”) and consequent cessation as a Partner of the LLP.

3. The capital contribution standing to the credit of Shri Bajrang Alliance Limited and all rights, interests and entitlements attached to its partnership interest have been settled, adjusted and discharged in accordance with the terms mutually agreed amongst the parties.
