1. The above financial results have been reviewed by the Audit Committee and approved thereafter by the Board of Directors in the meeting held on 13 Aug 2026 & these results have been reviewed by the Statutory Auditors of the company.
2. On the last hearing dated 23rd January 2026, the SLP in the Honorable Supreme Court has been admitted on merits and the stay on the matter continues. The appeals in the Honorable Supreme Court of India are admitted when the court finds strong merit in the case. The contingent liability in this matter shall stand as it is. Court fees amounting to Rs.24.05 lacs was deposited in the matter in April, 2026 and has been recognised as an expense in the current quarter.
3. Deferred tax assets Rs.2038.78 lacs (including Rs.984.26 lacs on account of unabsorbed business losses) as at 31st March, 2026 is expected to be realized, as company has enhanced its product portfolio and the new business strategy of deeper penetration, greater operational efficiency.
4. In accordance with IND AS-108 "Operating Segment", the company has only one reportable segment i.e. "Consumer Electronic Division".
5. The GST registration of the Company in Delhi remained suspended from 27 March 2026 to 29 May 2026, adversely impacting the Company's operations and turnover for the current quarter.
6. The figures for the corresponding previous period have been regrouped / reclassified wherever necessary, to make them comparable.
