ARRESTED IN AHMEDABAD

Life convict, who jumped parole twice, lived under new identity for years

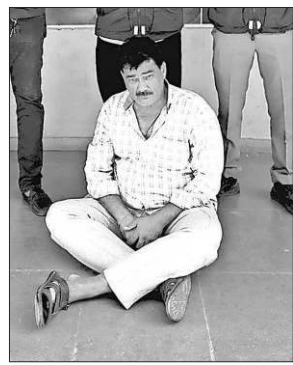
He was living with his second wife and her two children

A MURDER convict who jumped parole twice, changed his identity through an official gazette notification, and allegedly lived undetected in Ahmedabad for over a decade was arrested by the city Crime Branch Monday.

Satish Himmatlal Ruparelia, alias Bhikhu, alias Sanjay Thakkar, was convicted for the October 22, 1994, murder and decapitation of textile merchant Arvind Shah at Neelam Hotel in Ahmedabad's Shahibaug area.

According to the police, a headless body was found in a room of Neelam Hotel, which Ruparelia and fellow accused Rajan Panchal had rented. Both brought Arvind Shah from his shop in Kalupur to the hotel

room. They locked the room from inside, threatened Shah with a knife, and asked him to hand over the gold rings he was wearing, the chain around his neck, and cash. When Shah tried to snatch the knife away, a scuffle broke out and all of them were injured. Ruparelia and Panchal then stabbed Shah about 30-35 times and brutally murdered him. They also made away with Shah's gold ornaments and cash.

"Then, in order to prevent

the body from being identified, the accused decapitated the body. Later, they put the severed head in a bag, took it on a scooter and threw it in the Adalaj area," the police said.

In April 2000, the Additional City Sessions Court of Ahmedabad sentenced him to death for murder, robbery, and criminal conspiracy under the Indian Penal Code and the Bombay Police Act. The Gujarat High Court later commuted his death sentence to life imprisonment in an order dated August 2, 2001. In a statement, the police said it successfully located Ruparelia using intelligence, tactical surveillance, and groundwork, adding that he is being remanded back into judicial custody.

Ruparelia, who was released on parole in 2004, remained absconding till 2008, the police said. "During that time, a case of counterfeit currency notes was also registered against Satish alias Bhikhu Ruparelia at the Dariyapur police station in 2008. After that, he was again sent to jail. He was further sentenced to five years in prison in the counterfeit currency notes

case, but since he was already serving a life sentence, the court ordered that both sentences be served concurrently," the statement read.

Satish becomes Sanjay

The police further stated that Ruparelia was granted parole again in 2014 and officially changed his name from Satish to Sanjay in 2017. He was living with his second wife and her two children at Ratnagar Heights in the New Ranip area.

On his identity change, the police said, "People around him knew him only as Sanjay. Not only this, but the children living with him had no knowledge of his criminal history. Also, his family members, siblings, and 85-year-old father had no knowledge of the new residence he had built. Although his family members lived in Ahmedabad, he lived in a separate residence so that his identity and confidentiality were maintained."

The police further said Ruparelia had also started a finance business in the Prahladnagar area.

STATE GOVT SIGNS MoU WITH META

Soon, 20 citizen-centric services on WhatsApp

Services include grievance redressal assistance, income, caste and EWS certificates, ration card updates, revenue records and official affidavits

SOON CITIZENS in Gujarat will be able to avail income, caste and EWS certificates, update ration cards, revenue records and official affidavits through a single WhatsApp number.

The Gujarat government signed a Memorandum of Understanding (MoU) with Meta Platforms Inc in Gandhinagar on Monday for facilitating the service.

The initiative, in accordance with the recommendations of the Gujarat Administrative Reforms Commission (GARC) and under 'Sugam Digital Gujarat' initiative, will make nearly 20 citizen-centric services from five departments available via a WhatsApp chatbot. Under the 'Sugam Digital Gujarat' initiative, the state government has recently brought over 20 government services online.

"This MoU makes availing of government services more comfortable. A large number of

people use WhatsApp on their mobile phones so this makes it easier to access government services on a single WhatsApp number. WhatsApp, which is mostly used for marketing and commercial services, will now offer government services," a senior government official told The Indian Express, explaining how this makes it different from the recently launched online service. This will free citizens from navigating multiple web portals or standing in queues at government offices, saving both time and cost and strengthening transparency and accountability, the state government said.

"With the implementation of the MoU, the service delivery process will become simpler and real-time status tracking will become more robust. The state government intends to gradually integrate more services with the WhatsApp-based platform in future," the state government said in a statement.

The services that will be made available on WhatsApp include grievance redressal assistance, income, caste and EWS certificates, ration card updates, revenue records and official affidavits. The launch of the WhatsApp services is likely to take some time as customisation and integration of different platforms is required to be achieved.

"This might take some time so it is difficult to announce a timeline for the launch," the official said.

GARC assessment

The assessment of top 20 citizen services by the GARC based on application volume data from the Digital Gujarat portal (April 2024 - March 2025), the top 20 'most availed' services are clubbed into seven major categories. The GARC analysed the top 20 of over 400 services to spotlight citizen priorities and resource-intensive workflows. The data revealed that approvals are heavily clustered at the

mamlatdar/deputy mamlatdar level, creating structural bottlenecks where demand far exceeds processing capacity. Equally significant is the channel mix: while web portals and assisted kiosks remain the backbone of access, the growing use of mobile apps signals a gradual but essential shift toward digital self-service, it stated. However, the service timelines vary widely—from one to fifteen days—indicating uneven process design and scope for standardisation. These insights frame the detailed service-by-service analysis that follows, providing the evidence base for targeted reforms in automation, decentralisation, and mobile-first design.

On March 24, Chief Minister Bhupendra Patel launched the 'Sugam Digital Gujarat' initiative. The CM announced online simplification of 20 high-transaction services across five major state departments, based on the recommendations of the fifth report of GARC.

110 DENGUE CASES SINCE JANUARY

Vector-borne diseases, AMC begins monsoon preparations

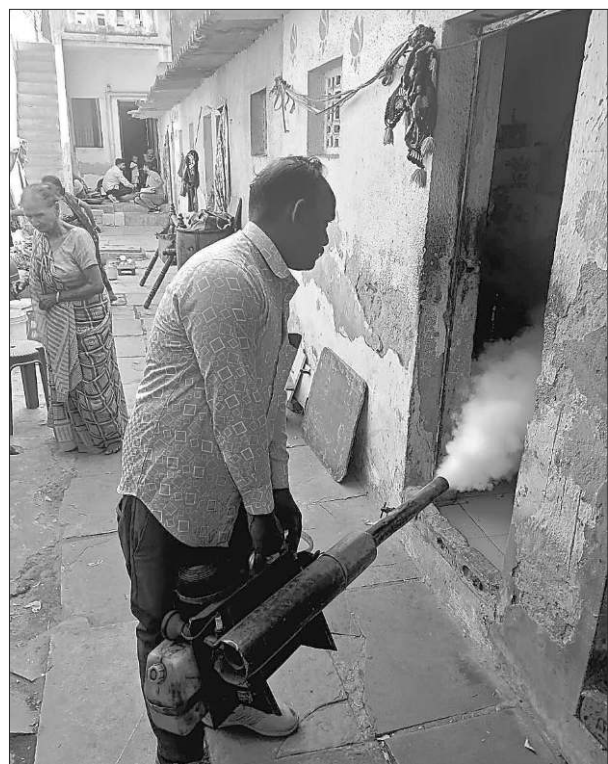
WITH 110 dengue cases reported in Ahmedabad city since January this year, even before the onset of monsoon, the Ahmedabad Municipal Corporation (AMC) has launched an intensive pre-monsoon action plan against vector borne diseases such as dengue, malaria and chikungunya.

As many as 104 of these 110 cases have been reported at government health establishments and the remaining at private health units.

Also, a total of 54 cases of malaria (Pv) and 11 cases of malaria (PF) have been reported from January so far.

In 2025, a total of 1,591 cases of dengue were reported in the city, including 1,347 cases in government hospitals and 244 cases in private health centres. While 784 cases of malaria (PV) and 177 cases of malaria (PF) were reported. A total of 577 mosquito breeding spots have been detected since January this year, while 88 construction sites have been issued notices and slapped penalties.

"If dengue or malaria cases are reported in any area, immediate anti-malarial action is taken and the patients are followed up. No outbreak situation has been reported at present, but teams have been kept ready for such a situation. Fever survey and contact tracing are being done by the Malaria Department and Urban Health Centre staff. Awareness videos related to vector-borne disease control and mosquito breeding sites have been broadcast at the city's smart city VMD stations and cinema halls to raise public awareness," AMC authorities

At present, a total of 274 fogging machines are operational in the city. A total of 17,65,047 blood samples have been taken in the year 2025 and 6,53,148 in the year 2026, so far.

"The AMC is implementing the collection and removal of unclaimed tires, debris and water-logged scraps. The work of removing vegetation and waste from the ponds is also being monitored. In addition, intensive checking is being carried out in major government, semi-government units, educational and non-educational units of the municipal corpor-

ation, hospitals and commercial units of the city," said an official from the AMC's Health Department. In addition, separate mapping of areas and units where mosquito breeding is seen in large quantities is also being done. Immediate disease control and preventive measures are being taken in positive cases of fever, malaria, dengue and chikungunya. Complaints regarding mosquito breeding by citizens can be registered at the comprehensive Redressal system (CCRS) and also at the Malaria Ward Office and City Civic Centre.

Fake Dubai firm, bogus projects: Pune police bust fraudulent call centre in Ahmedabad

PUNE CITY Police busted a fraudulent call centre operating from Ahmedabad in Gujarat and have arrested two persons for allegedly duping victims by promising overseas business projects and call centre contracts in the name of a Dubai-based company.

According to police, a complaint was lodged at Kharadi police station on April 25 after the complainant alleged that unidentified persons, posing as representatives of a project development consultant company based in Dubai, convinced him to invest money for setting up a call centre project.

The accused allegedly promised to provide projects and technical support for the business setup, but after taking over Rs 70 lakh from the complainant, did not deliver any project and allegedly cheated him.

During the investigation, police analysed technical leads

and traced the operation to Ahmedabad.

Investigators found that the suspects were allegedly contacting victims over phone calls while pretending to operate from Dubai.

Police said the accused had set up an unauthorised company officering human Resources solutions and were using pseudonyms while speaking to clients.

Acting on the clues obtained from analysis of the digital trail, a team from Kharadi police station raided the fraudulent call centre in Ahmedabad and seized equipment including computer CPUs, laptops, mobile phones, a CCTV DVR machine and documents containing scripted conversations purportedly used while speaking to victims in the name of the fake Dubai-based company.

The arrested accused have been identified as Khushi Kausal Parmar alias Sanvi Shah, a resident of Rajkot and Tushar Maheshkumar Talpada a resident of Ahmedabad.

Pune jewellery store heist: 2 arrested from Surat, ornaments worth over Rs 9 lakh seized

THE SURAT police arrested two persons for their alleged involvement in a jewellery heist worth 77.22 lakh from a jewellery showroom in Maharashtra's Pune district last month.

The two accused were handed over to Pune Crime Branch personnel on Monday. Jewellery worth Rs 9.40 lakh, seized from their possession, was also handed over. The Pune police nabbed the four other accused in the case earlier. On a tip-off, a team of Amroli police intercepted the two youths on Sunday night. Gold and silver ornaments were found in their possession upon checking, police said.



The accused

The police identified the two as Sumit Raju Bengali (22) and Rahul alias Kalu Gaud (21), both residents of the Amroli area in Surat. Both have several pending cases against them, police said. During questioning, the duo allegedly admitted to being part of a gang of six who were involved in a gold and silver jewellery heist at the Kshamta Jewellery showroom in Pune on April 23.
