Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and with reference to the disclosures made by the Company on August 03, 2024, February 05, 2025, December 08, 2025, and February 14, 2026, we wish to inform you that the Hon'ble High Court of Judicature at Bombay, vide its order dated April 17, 2026, has referred the questions of law arising in the writ proceedings filed by the Company to a Larger Bench for adjudication.

In continuation of its earlier directions (as disclosed on February 14, 2026), the Hon'ble Court has further directed that all interim orders passed in the matter, including the direction that no further action shall be taken pursuant to the impugned show cause notice/order until final orders are pronounced, shall continue to remain in force until the Larger Bench decides the issues.
