Sub.: Outcome of Board Meeting dated May 07, 2026 - Allotment of 90,00,000 fully paid-up Equity Shares of Rupees 10/- each upon conversion of warrants into Equity shares, on Preferential Basis

In furtherance to our letter dated November 07, 2024, and pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we hereby inform you that the Board of Directors of the company in its Meeting held today i.e. Thursday, May 07, 2026, has approved allotment of 90,00,000 fully paid up equity shares of the face value of Rs.10/- each to following Promoter and Non-Promoter Group allottees, pursuant to exercise of their right to convert share warrants (the "Warrants") into equity shares and the details of the said warrants are given below:

The allotment has been made for cash, upon receipt of the remaining exercise price of Rs.30/- per share warrant (being an amount equivalent to 75% of the warrant exercise price of Rs.40/- per warrant), aggregating to Rs.27,00,00,000/- (Rupees Twenty-Seven Crore Only).

The equity shares so allotted on the exercise of warrants on a preferential basis shall rank pari passu with the existing equity shares of the Company in all respects.

Consequent to the aforesaid allotment, the paid-up equity capital of the Company has increased from Rs.25,48,07,000/- consisting of 2,54,80,700 Equity Shares of Rs.10/- each to Rs.34,48,07,000/- consisting of 3,44,80,700 Equity Shares of Rs.10/- each.
