This is to inform you that ICICI Prudential Mutual Fund (the Fund) including iSIF under its various schemes/investment strategies holds equity shares of CMS Info Systems Ltd.(the company), listed on your stock Exchange.

The Fund under its schemes/investment strategies has carried out sale of 2,63,446 shares of the Company on April 09, 2026. As a result, the shareholding of the Fund has decreased by more than 2% of the paid-up capital of the company as compared to previous disclosure on September 04, 2025 for 5.29%.
