Dear Sir / Madam,

In terms of Regulation 31(1) of the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (“**SAST Regulations**”), I, Shreekrishna Mukesh Gupta, being the Promoter of Lloyds Metals and Energy Limited (“**LMEL**”), have entered into a Non-Disposal Undertaking (“**NDU**”) dated 25th August 2026 with SBICAP Trustee Company Limited, acting as the Security Trustee, in connection with a Rupee Term Loan Facility availed by LMEL.

Accordingly, I hereby furnish the details of the NDU created in respect of 1135700 (0.20%) equity shares of LMEL held by me, in the prescribed format enclosed herewith.

I further clarify that the NDU has been provided as part of the financing arrangements in connection with the aforesaid Rupee Term Loan Facility and represents a customary arrangement in financing transactions of this nature and quantum. Pursuant to the NDU, the relevant shares are subject to contractual restrictions on their disposal during the applicable period and in accordance with the terms of the financing documents.

For the avoidance of doubt, I have provided an NDU in respect of the shareholding in LMEL and have not created a pledge over such shares. The legal and beneficial ownership of the shares continues to remain with me, and the voting rights attached to such shares continue to be exercisable by me, subject to the terms of the NDU and the applicable financing documents. I also continue to be entitled to the dividends and other economic benefits arising in respect of such shares, subject to applicable law and the terms of the financing documents.

There has been no transfer of the shares pursuant to the NDU to any third-party demat account. The shares continue to be held in the my demat account, subject to the restrictions arising under the NDU and the related financing arrangements.
