The financial results were reviewed by the Audit Committee and approved by the Board of Directors in their meetings held on 29th May 2026. The financial results are prepared in accordance with the Indian Accounting Standard (IndAS) as prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable. 3. The Government has notified and brought into force substantial provisions of the Code on Social Security, 2020 ("Social Security Code"), the Occupational Safety, Health and Working Conditions Code, 2020, the Industrial Relations Code, 2020 and the Code on Wages, 2019 (collectively the "Labour Codes") on 21st November 2025, which consolidates, subsumes, amends and replaces numerous existing central labour legislations. The Ministry of Labour and Employment had earlier released draft rules for the Code on 13th November 2025. Subsequently, on 21st November 2025, the Government has notified and brought into force substantial provisions of the Labour Codes. However, certain specific rules and corresponding State-level notifications are yet to be notified. The figures for the previous quarter and Year ended 31st March, 2025 were audited by erstwhile auditors and the same has been relied upon.
