Independent Auditor's Review Report on Interim Un-Audited Financial Results

To the Board of Directors of

We have reviewed the accompanying statement of Standalone unaudited financial results of **M/s. SOPHIA TRAEXPO LIMITED** ('The Company') for the quarter ended 30th June 2026 ("the Statement"), being submitted by the company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("the Listing Regulations").
