Pursuant to the provisions of Regulation 30, read with Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation of our earlier intimations dated 5th June, 2024, the Company hereby wishes to further inform that the appeal that was filed before the Hon'ble Regional Director ("RD"), North-Western Region, Ministry of Corporate Affairs, Ahmedabad against the Order of Registrar of Companies ("ROC") dated 30th May, 2024, has been adjudicated by RD vide its order dated 1st December, 2025, wherein appeal of the Company is partially allowed.

The Company may explore possibility of seeking further available remedy against the order of the Appellant authority whereby the contentions/appeal of the Company and its officers was not fully considered.

Further, the details as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Schedule III and the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November, 2024, on the above-mentioned penalty issue is enclosed as Annexure-I.

("Votorantim") in the Company. Effective from 16 th April 2019, Votorantim ceased to be a promoter of the Company on acquisition of majority shares by current promoter True North Fund VI LLP pursuant to the Share Purchase Agreement dated 12 th November 2018 entered into between True North fund VI LLP and Votorantim. Pursuant to the Regional Director order dated 1st December 2025, the appeal has been partially allowed whereby penalty u/s 90(4A) of the Companies Act, 2013 has been dropped/deleted. Details of penalty is forming part of Table "A" below. |
