#### Meeting Details:

The AGM was held on Wednesday, June 10, 2026, at 10:30 a.m. (IST). The Cut-off date for e-Voting was June 3, 2026. The Meeting started at 10:30 a.m. and concluded at 01.50 p.m. (IST) (including the time allowed for e-Voting at the AGM).

#### Meeting Mode:

The Meeting was conducted through VC/Audio-Visual Means, in compliance with all the applicable provisions of Companies Act, 2013 (“the Act”) and the Rules made thereunder and Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“**SEBI Listing Regulations**”) read with General Circulars Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 5, 2020, and subsequent circulars issued in this regard, the latest being 3/2025 dated September 22, 2025, collectively referred as (“**MCA Circulars**”).

The Chairman of the Board, Mr. N. **Quorum:**

The requisite quorum as required under Section 103 of the Act was present throughout the Meeting.

**E-Voting during the Meeting:**

The Members attending the Meeting who had the right to vote but had not cast their votes through Remote e-Voting were given the opportunity to vote using the e-Voting platform of NSDL, which was activated from the beginning of the Meeting and till 15 minutes after the conclusion of the proceedings.

**Proceedings of the Meeting:**

Ms. Delnaz Dara Harda, Company Secretary, welcomed the Members to the Meeting and briefed them on certain points relating to the participation at the Meeting.

The Chairman informed the Members that the proceedings of the Meeting was video recorded and a live streaming was being webcast on the website of National Depository System Limited (“NSDL”). The Company had taken requisite steps to enable Members to participate and vote on the items of businesses considered at the AGM.

The requisite quorum for the Meeting being present, the Chairman called the Meeting to order. Statutory Registers under the Act, and other relevant documents as required to be kept open in terms of the resolutions provided in the AGM Notice, were available for inspection of the Members electronically.

Since the Auditor’s Report on the Financial Statements (Standalone as well as Consolidated) for the year ended March 31, 2026, did not have any qualifications, reservations, observations, adverse remarks or disclaimer, the same was not required to be read. Also, the Notice convening the Meeting along with text of resolutions and explanatory statements were taken as read.

In his opening remarks, the Chairman provided a brief overview of the global and domestic economic environment, evolving consumer preferences and the growth of digital commerce. He outlined the Company's performance during FY 2025-26. He also emphasized on key focus areas including digital and AI initiatives, business transformation, sustainability roadmap and long-term growth outlook.

Mr. Sunil D'Souza, the Managing Director & CEO, then proceeded with a comprehensive presentation to the Members. He provided a concise overview on key highlights and financial performance for the financial year 2025-26. Additionally, he discussed the progress made in relation to strategic priorities, assessed the business performance of India and International business along with Company’s subsidiaries and joint-venture companies.

Pursuant to the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had provided the Remote e-Voting facility to the Members in respect of businesses to be transacted at the AGM. The Remote e-Voting commenced at 9.00 a.m. on Saturday, June 6, 2026 and ended at 5:00 p.m. on Tuesday, June 9, 2026.

Further, the Company had also provided the facility for e-Voting during the AGM on all the resolutions to facilitate the Members who had not cast their votes earlier through Remote e-Voting.

2) To receive, consider and adopt the Audited Consolidated Financial Statements of the Company for the financial year ended March 31, 2026, together with the Report of the Auditors thereon. <b>(Ordinary Resolution)</b>
3) To declare a dividend of Rs. 10 per equity share of the face value of Re. 1 each (1000%), of the Company for the financial year ended March 31, 2026. <b>(Ordinary Resolution)</b>
4) Re-appointment of Mr. Ajit Krishnakumar (DIN: 08002754) as Director, who retires by rotation in terms of Section 152(6) of the Companies Act, 2013 and being eligible, seeks re-appointment. <b>(Ordinary Resolution)</b>
<b>Special Business</b>
5) Re-appointment of Dr. K. P. Krishnan (DIN: 01099097) as an Independent Director of the Company for a Second Term of 5 Years commencing from October 22, 2026. <b>(Special Resolution)</b>
6) Ratification of remuneration payable to M/s. Shome & Banerjee, Cost Accountants (Firm Registration Number 000001), Cost Auditors of the Company for the financial year ending March 31, 2026. <b>(Ordinary Resolution)</b>

The Chairman then invited the Members to express their views, suggestions and questions, on the operations and financial performance of the Company and related matters. The Members were given an opportunity to speak in the order in which they had registered their names. The Chairman appropriately responded to the queries raised by them.

The e-Voting facility remained available until 15 minutes after the conclusion of the proceedings, allowing Members who had not cast their votes to cast their votes earlier. Once the e-Voting process was finished, the Company Secretary officially declared the Meeting closed.
