This is to inform you that ICICI Prudential Mutual Fund (the Fund) including iSIF under its various schemes/investment strategies holds equity shares of PVR INOX Ltd. (the Company), listed on your stock Exchange.

The Fund under its schemes/investment strategies has carried out net sale of 8,66,673 shares of the Company on April 24, 2026. As a result, the shareholding of the Fund has decreased by more than 2% of the paid-up capital of the company as compared to previous disclosure on May 16, 2024 for 7.11%.

It may be further noted that the schemes/investment strategies of the Fund have carried out net sale of 23,53,378 shares of the Company from the last filing submitted on May 16, 2024 (for positions held as on May 15, 2024).

The holding by schemes/investment strategies of the Fund are from an investment perspective and not with the objective of seeking any controlling interest. However, the disclosures in this regard as required under Regulation 29(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 is enclosed herewith.
