With reference to the captioned subject and reference, we refer to the earlier intimations submitted by us in relation to the proposed issue of up to 50,00,000 (Fifty Lakhs) Warrants Convertible into Equity Shares of **OsiajeeTexfab Limited ("Company")** to the private investors, on a preferential basis ("Proposed Preferential Issue") in accordance with applicable laws including the provisions specified under Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI ICDR Regulations").

2. Application for In- principal Approval for the Proposed Preferential Issue was submitted to BSE Limited .
3. The shareholders of the Company had approved the proposal for the Proposed Preferential Issue through Postal Ballot held on **March 12, 2025**.
4. The Company has not received the "In-principle Approval" for the Proposed Preferential Issue from BSE Limited ("BSE") under Regulation 28(1) of SEBI LODR Regulations till now.

In this Regard, Prevailing market conditions and current market dynamics are not favourable for proceeding with the issue at present. In view thereof, we hereby inform you that the Proposed Preferential Issue of warrants stands withdrawn. As a result, the Company will not be proceeding further with the issue of
