Dear Sir/Madam,

This is with reference to your email dated April 13, 2026, seeking clarification regarding a message circulating on the Telegram Channel 'Chase Alpha-SEBI REG', which claims that A-1 Limited has bought a 20% stake in Yashvi Lifesciences.

We would like to categorically clarify and place on record that "the information circulated in the aforementioned Telegram channel is completely false, baseless and fabricated."

Please note the following clarifications:

- 1." No Acquisition": A-1 Limited has "not" acquired any stake, of 20% or otherwise, In Yashvi Lifesciences. Furthermore, there is no such proposal yet arrived under consideration by the Board of Directors.
2. " No Affiliation": The company has absolutely no affiliation connection, or association with the Telegram channel " Chase Alpha" or the individuals operating it.
- 3."Investor Protection": We strongly condemn the dissemination of such misleading and unverified information, which appears to be aimed at manipulating investor sentiment. In order to protect the interests of our shareholders and the general public, we will immediately file a formal clarification announcement on the BSE portal to dispel the rumours.
- 4." Legal Action": The management is currently evaluating the matter and will take appropriate actions against the entities responsible for spreading the news.

We reiterate our commitment to the highest standards of corporate governance and transparency. We assure the Exchange that A-1 Limited strictly complies with Regulation 30 of the SEBI(LODR) Regulations,2015, and any material event or unpublished price-sensitive information (UPSI) is, and will always be promptly disclosed and officially disclosed to the Exchanges.
