Junagadh High Court's big order in the Panchayat election matter

AAP members will vote under police guard, TDO-DDO instructed to ensure full compliance of the order; BJP body elected

Junagadh
The political atmosphere has become very heated even before the elections for the president and vice-president of Junagadh Taluka Panchayat were held, with the arrest of Sanjay Pagdar, a member of the Aam Aadmi Party of Bagdu Taluka Panchayat, on the charge of cheating. A complaint of cheating of seven lakh rupees was registered against Sanjay Pagdar at the Junagadh Taluka Police Station two days ago, on the basis of which he was arrested by the police yesterday (May 24). Following this arrest, the Aam Aadmi Party has made serious allegations against the Bharatiya Janata Party and the

police administration, calling it the murder of democracy. In the Junagadh Taluka Panchayat elections, BJP and AAP were tied. 9 BJP members were present at the time of voting, while 1 AAP member was arrested, 2 members were late by 1 minute and 1 member was absent, and the BJP body was elected. The entire matter reached the High Court. In this matter, the court ordered that the applicant be taken to the polling station in police custody, on the condition that the applicant will bear the expenses. The applicant should be taken directly from the detention center to the polling station and brought back to the detention center

immediately after voting. It was also ordered to keep the election process open until the entire process is completed. Along with this, the TDO-DDO has been instructed to ensure full compliance with the order. AAP member had filed an application in the High Court. It was submitted by the applicant in the High Court that he was taken into custody on 24-05-2026 in a case related to FIR No. 11203025260323/2026 registered in Junagadh Taluka Police Station, when the election of the Chairman and Vice Chairman of Junagadh Taluka Panchayat was to be held at 11 am on the same day. The file reached the court after a delay of 2 hours and 15 minutes. The matter was presented in the court at 9:30 am and the court instructed the registry to send the file immediately. However, the file reached the court at 11:45 am after a delay of about 2 hours and 15 minutes. Maithili Mehta, Additional Public Prosecutor, appearing for the government, strongly opposed the application by filing a late application with the intention of obstructing the election process. She argued that the FIR was registered on 22-05-2026 and the application was filed late only with the intention of obstructing the election process. Moreover, the seriousness of the crime is such that it is not appropriate to show any leniency towards the applicant. It cannot be said that the applicant has been arrested only to deprive him of his right to vote just because the election is being held. The court noted that the posts of Chairman and Vice Chairman of Junagadh Taluka Panchayat are important and even a single vote can affect the result. Therefore, in the interest of justice, the court immediately issued an interim order. The court ordered that the petitioner be taken to the polling station with police escort (seizure), on the condition that the petitioner bear the expenses thereof, to the polling station. The petitioner should be taken directly from the detention center to the polling station and brought back to the detention center immediately after polling. It was also ordered that the election process should be kept open until the entire process is completed. TDO-DDO directed to ensure full compliance of the order. The court also directed the registry to convey a copy of this order to the parties concerned through all necessary means. The Additional Public Prosecutor was also directed to inform the concerned TDO and DDO of the order by telephone and ensure full compliance of the order. The court has posted the matter for further hearing on June 10, 2026 and has also allowed direct service.

Petition in High Court to add biological father's name in documents

Girl lived with stepfather since childhood due to mother's remarriage, moved to live with stepfather after mother died of Covid



Ahmedabad
A young woman's school records listed her stepfather, who raised her after her mother remarried. The 20-year-old applicant claims that the documents no longer reflect her identity or family reality. After the girl lost her mother in the COVID-19 pandemic, she returned to live with her biological father in Gandhinagar. But when she tried to apply for official documents like a passport and visa, she faced difficulties due to the difference in names. She has now filed a petition in the Gujarat High Court seeking to replace her stepfather's name with her real father's name in her school leaving certificate and mark sheets. The girl, a resident of Mansa Taluka, has filed a petition in the Gujarat High Court. She has requested that her stepfather's name be removed from her school documents and her real father's name be added. Mother went with the girl when she remarried. According to the petition, her parents separated through customary divorce when the girl was young. Her mother later remarried another person and took the girl with her to live in Bharuch district. Since she studied up to class 10 in Bharuch, her school records and mark sheets issued by the Gujarat

Secondary and Higher Secondary Education Board had her stepfather's name. The petition states that the girl returned to live with her father after her mother died and that her stepfather's name was entered in her records without any legal adoption process or formalities. The girl lost her mother during the Covid period and returned to live with her biological father in Gandhinagar. She has been living with him since then. High Court issues notice to Education Board and Gandhinagar school authorities. Last year, she approached the Mansa court seeking directions to the school and education board authorities to correct her documents. On February 28, the court had reportedly ruled that the school should make the necessary changes in its records. However, since she also wanted to get her marksheet corrected, she approached the high court and argued that the discrepancy in her name was hindering her from getting a passport or visa. Replacing her stepfather's name with her biological father's name would solve her problem. The high court has issued notices to the education board and the Gandhinagar school authorities seeking their replies and posted the matter for further hearing on June 22.

Businessman beheaded in hotel, stuffed dead body in travel bag and dumped in Adalaj

Man who killed him in Ahmedabad in 1994 and sentenced to death, caught after 13 years



Ahmedabad
The Ahmedabad Crime Branch has successfully tracked down and apprehended a high-profile death row convict who had been on the run for more than a decade after jumping parole in 2013. The man was originally convicted in a brutal murder and robbery case that took place in Ahmedabad's Neelam Hotel in 1994. Packed in a bag and thrown in Adalaj In the year 1994, accused Satish and his accomplices targeted businessman Arvind Shah with the intention of robbery. They killed the businessman in a room of Neelam Hotel in Ahmedabad. Crossing the limits of cruelty, accused Satish separated the businessman's head from the torso, packed his dead body in a travel bag, took it all the way from Ahmedabad to Adalaj and threw it there. In this bloody and hair-raising case, the court, keeping in mind the cruelty of the crime, sentenced the accused to the severe punishment of hanging (death penalty). In the year 2000, the Sessions Court sentenced to death Satish Himmatal Ruparelia (alias Bhikhu / alias Sanjay Thakkar), identified as the main accused in Sessions Case No. 56/1995, was sentenced to death by the Additional City Sessions Court of Ahmedabad in April 2000 for murder, robbery and criminal conspiracy under the Indian Penal Code (IPC) and the Bombay Police Act. The sentence was pronounced after a thorough investigation into the incident of October 22, 1994, where cloth merchant Arvind Shah was called to a hotel on the pretext of trading at a discounted price, robbed of cash and gold ornaments, and then beheaded to conceal his identity. Satish was granted parole in 2013 and later surrendered after being convicted and later released on parole while in prison. In 2013, he violated the terms of his bail, did not surrender to the prison authorities and went underground.

Recruitment of 3,966 teachers in Gujarat

has clarified that the recruitment process will be completely transparent. The selection of candidates will be done on the basis of their educational qualification, Teacher Eligibility Test (TET) marks and the prevailing recruitment rules of the government.
