The Rights Issue offer opened on Thursday, 26th February, 2026 and closed on Friday, 06th March, 2026.

Pursuant to the finalisation of the basis of allotment of the Rights Issue, in consultation with MUFG Intime India Private Limited (Formerly Link Intime India Private Limited) ("Registrar to the Issue") and as approved by BSE Limited ("BSE"), being the Designated Stock Exchange for the Issue, the Rights Issue Committee, at its meeting held today, i.e., on Monday, 09th March, 2026, have inter-alia considered and approved the allotment of 45,76,305 fully paid-up Equity Shares of Face Value of Rs. 10/- each on Rights Basis to the eligible shareholders and/or renouncee(s) in terms of the Letter of Offer dated 13th February, 2026, at an issue price of Rs. 546/- per Equity Share (including a premium of Rs. 536/- per Equity Share).
