ON CONSTITUTIONAL AMENDMENT TO WOMEN'S QUOTA, DELIMITATION

Oppn says BJP's deceitful chariot has been stopped

New Delhi, April 17

AFTER THE CONSTITUTION (One Hundred and Thirty-First Amendment) Bill, 2026, failed to get the Lok Sabha's seal of approval on Friday, the Opposition hailed it as "historic", saying the BJP-led NDA government used an "unconstitutional trick" in the name of women to break the Constitution.

In his first reaction after the Bill failed to make its way through the Lower House, Leader of Opposition Rahul Gandhi of the Congress posted on X, "The amendment bill has fallen. They used an unconstitutional trick in the name of women to break the Constitution. India has seen it. INDIA (bloc) has stopped it. Hail the Constitution."

Samajwadi Party (SP) president Akhilesh Yadav said the BJP's "deceitful chariot" has been stopped once again. "Now they'll say their efforts fell short," said the former UP CM, who leads the largest opposition party in the Lower House after the Congress.

INDIA bloc constituent and Tamil Nadu Chief Minister M K Stalin said the state had "defeated Delhi".

"On April 23 (elections), we will defeat Delhi's arrogance — and the slaves who support that arrogance — together," wrote Stalin, posting a portrait of him setting fire to a copy of the delimitation Bill.

The Congress's communications chief Jairam Ramesh said, "The nefarious and mischievous attempt of the PM and HM to link their dangerous delimitation proposal to women's reservation has been decisively defeated in the Lok Sabha."

"This is a win for our democracy, our federalism, and the Constitution. This also calls into question the legitimacy of the non-biological, non-grihasthi PM," Ramesh, a Rajya Sabha MP, said in a statement.

Close to vote, government realised Bill will fall, placed burden on Opposition

HOURS BEFORE THE Bill to amend the Constitution to provide for women's reservation and delimitation was put to vote in the Lok Sabha, it had become clear to the government the numbers did not add up to two-thirds of those present in the house. But it has been learnt that BJP leaders and sources in the government said they would not withdraw the Bill; rather they would have it fall at the hands of the Opposition.

In a last ditch attempt to salvage the Bill, the ruling party did make attempts to reach out to the Akhilesh Yadav-led Samajwadi Party and some other opposition parties during the day. They also seemed to think that when the Bill would be brought to vote, sections within the

Opposition would support it given that they would have to face questions in the elections immediately due.

But the Congress had clearly communicated to all in the INDIA bloc that the Bill had to be stopped under all circumstances. The Opposition believed the women's reservation pitch was just a facade; the real intention was to increase the number of Assembly and Lok Sabha constituencies in states, and then delimitation i.e., redrawing these based on population. So, any outreach by the ruling NDA was spurned by the INDIA bloc.

Both the ruling party and the Opposition thus stuck to their positions. In this backdrop, BJP leaders and ministers huddled together in a meeting held by Union Home Minister Amit Shah in Parliament to deliberate on the strategy ahead with regard to the Bill.

Modi government were clear: they should implement 33% reservation for women in the existing Lok Sabha set-up for the 2029 elections.

"This has been the consistent demand of the entire Opposi-

tion ever since September 2023 when the Parliament unanimously passed the Nari Shakti Vandan Act 2023 - which finally got notified only late last night," said the Congress leader.

The Trinamool Congress's

(TMC) Deputy Leader in the Rajya Sabha, Sagarika Ghose, described the Lok Sabha vote as a "historic defeat" of the government's "devious attempt" to change the country's political map.

Udhaynidhi: Retaliate against BJP by backing DMK

TAMIL NADU DEPUTY Chief Minister Udhayanidhi Stalin on Friday asked people to utilise the April 23 Assembly elections to "give back" to the BJP-led Central government for not providing adequate funds to the state.

He said people should retaliate by denying space to the saffron party and its ally, the AIADMK, and instead give a decisive mandate to the DMK.

Addressing a poll campaign in Tiruppur district in support of the DMK-led Secular Progressive Alliance candidates, he claimed that the pace of development in the industrial district could be sustained only if the DMK returned to power.

"Did the BJP government provide funds or projects to Tamil Nadu. People should retaliate against the vindictive BJP for not providing central schemes or funds. Give back to the BJP by defeating them in the Assembly elections," he said while campaigning for candidates Jayakumar (Udumalpettai) and A Sudhakar (Pollachi), state minister M P Saminathan, who is contesting from Kangeyam constituency, and Dharapuram candidate Dr Indrani.

The DMK youth wing secretary lauded Tiruppur district's industrial growth and promised further development under DMK rule. He also highlighted the DMK's poll promises, including doubling the monthly assistance for women to ₹2,000, providing free laptops for students, and offering a ₹8,000 one-time voucher for homemakers to purchase household electrical appliances.

TMC bets on SIR backlash to corner BJP in Bengal

WITH THE ELECTION Commission (EC)'s Special Intensive Revision (SIR) of electoral rolls now over in West Bengal, and 27 lakh voters left out after adjudication, the ruling Trinamool Congress (TMC) is seeking to use voter exclusion as a key plank in Assembly polls, hoping it could consolidate the party's base and raise turnout. "The people of Bengal... know this process (SIR) was initiated to delete names (of genuine voters)... The SIR will generate backlash for the BJP," TMC spokesperson Arup Chakraborty said.

TMC leaders said the party has already been working at the grassroots for months to shape opinion and mobilise voters around the SIR issue.

"The fear the BJP has created through the SIR has convinced

TMC supporters that its sole purpose is to defeat the TMC," a senior TMC leader said. At the core of the TMC's strategy is sustained booth-level engagement. TMC leaders say their Booth Level Agents (BLAs) have been deployed across 80,000 booths, with party workers tracking changes to rolls, assisting voters with documentation, and flagging discrepancies.

Chief Minister Mamata Banerjee and the TMC have linked the SIR exercise to concerns around citizenship and dignity.

POLL POSITION

Passport row: No SC relief for Pawan Khera

THE SUPREME COURT on Friday refused to entertain a plea of Congress leader Pawan Khera seeking protection against possible coercive action till April 20 in a case lodged against him for levelling allegations against Assam Chief Minister Himanta Biswa Sarma's wife.

The top court asked Khera to move a court of competent jurisdiction in Assam for anticipatory bail in the case. At a press conference on April 5, Khera alleged that the Assam CM's wife, Riniki Bhuyana Sharma, had multiple passports and foreign property, which were not declared in Sarma's election affidavit for the April 9 Assembly polls in that state. The CM and his wife rejected the allegations as false and fabricated.

Bengal candidates report asset surge

THE TMC'S JANGIPUR candidate Jakir Hosain had, in the 2021 West Bengal Assembly polls, declared owning assets worth Rs 67 crore. Five years later, his 2026 poll affidavit showed assets doubling to more than Rs 133 crore, making him one of the wealthiest candidates. And he is not alone.

The BJP's Purulia MLA Sudip Kumar Mukherjee, who is seeking re-election from the same seat, saw an eye-watering 2,344% rise in assets from ₹45 lakh in 2021 to ₹11 crore in 2026. Several prominent candidates seeking reelection in the first phase of the West Bengal Assembly polls have declared a sharp rise in assets, data compiled from their affidavits show.
