In continuation to the above, we would like to inform that the Company has received an assessment order with nil demand dated December 15, 2025, for dropping the proceedings under section 73 of CGST Act, 2017, from Assistant Commissioner of State Tax, Ward 203, Zone-11, Delhi against the said SCN.
