To the Members of

- 1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of **POPEES CARES LIMITED** (the "Company"), which was previously known as **ARCHANA SOFTWARE LIMITED**, for the quarter and half year ended September 30, 2025 (the "Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 2. This Statement, which is the responsibility of the Company's Management and approved by the Company's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. - 1) On 10 October 2023 a BSE listed company Archana Software Limited was substantially acquired by the current Acquirer & Promoter and subsequently on 05-04-2024 the name of the said company was changed to Popees Cares Limited. The initial share Capital of the company was Rs.604.43 Lacs. Since the accumulated losses up to 30 September 2025 was Rs.686.12 Lakhs the equity balance as at 30 September 2025 was reduced to minus Rs,81.69 Lakhs, the financial statements have been prepared on the assumption of "Going Concern Basis" though the net worth of the company has already eroded. The ability to continue as a going concern in spite of erosion of the net worth to such extent is dependent upon infusion of additional funds from its promoters/shareholders and additional business revenue. The company has been hopeful to resolve these issues in the foreseeable future and has also during the previous year generated revenues and is expecting to generate revenues in future which should improve its financial position. Alternatively, it would infuse fresh capital to improve the working capital. In the expectation of the successful outcome of the above, the accounts have been prepared on a "Going Concern Basis".
- 2) Above results were reviewed by Audit Committee and approved by the Board of Directors in their Board Meeting held on 14 November, 2025
- 3) Figures for the prior periods/years have been regrouped and/or classified wherever considered necessary.
