In view of the above, we wish to make a disclosure in compliance with Regulation 29(1) of the Takeover Regulations which is enclosed herewith as Annexure 1.

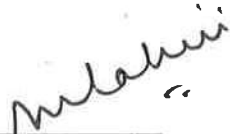
