AfD LANDSLIDE | Far-right surge in German state election alarms mainstream parties as nationalist allies cheer result

‘GRAVE MOMENT’ FOR EUROPE, SAY LEADERS

Berlin: Mainstream politicians across Europe sounded the alarm after the far-right Alternative für Deutschland (AfD) swept to a historic victory in Germany's Saxony-Anhalt state election, while nationalist leaders hailed the result.

The AfD won 43.8% of the vote in Sunday's election, more than double its showing five years ago, but fell three seats short of an absolute majority. It secured 39 seats in the 83-member state parliament.

France's European Affairs Minister Benjamin Haddad called the result "a very grave moment for Europe". "We must listen with humility to the anger, fears and worries and duly respond to these concerns. But nationalism and xenophobia will never be the answer," Haddad said.

France's Finance Minister Roland Lescure said the result sent a "very, very worrying signal" and warned of a "populist wave" spreading around the world. Poland's Foreign Minister Radoslaw Sikorski called the victory "a very worrying sign", while PM Donald Tusk said "only idiots or traitors can rejoice at the triumph of the AfD in Germany".

Italy's Foreign Minister Antonio Tajani described the result as "terrible news", saying the AfD was "antithetical to liberal and western values".

Nationalist figures, however, celebrated the result.

Trump floats 'New America' for New Mexico

Washington: US President Trump appeared to float re-naming New Mexico "New America", sharing a map of the state bearing the new name. The White House later reshared the image.

Trump also posted an AI-generated video showing him placing "America" over a road sign reading "Welcome to New Mexico", claiming "many people" had suggested the change. The White House has announced no move to re-name the state.

The posts drew criticism from Democratic leaders.

"New Mexico's name isn't up for debate. It's been since before the US existed," Governor Michelle Lujan Grisham said, accusing Trump of trying to distract Americans from the Iran war and rising prices. Former Interior Secretary Deb Haaland said: "New Mexico is not for renaming. Not up for sale."

Senator Ben Ray Lujan said "it's New Mexico, always has been and always will be".

Elon Musk congratulated the AfD with a "Well done!" on X, while US President Donald Trump posted a screenshot of the projected result on Truth Social without comment.

Russia's presidential envoy Kirill Dmitriev hailed

a "historic win for the pragmatic AfD", while former Hungarian PM Viktor Orbán called it "a huge night for Germany and Europe". France's National Rally, which expelled AfD from its European parliamentary

group two years ago, kept distance. RN chief Jordan Bardella said his party had no plans to revive the alliance. Friedrich Merz's Christian Democratic Union finished a distant second with 17.2% of the vote.
