In furtherance to our intimation dated January 31, 2026, informing that the Board of Directors of the Company had approved (i) infusion of funds by way of investment in International Gemmological Institute BV ("IGI Belgium"), a wholly-owned subsidiary ("WOS") of IGI India, and investment by IGI Belgium in International Gemological Institute Inc. ("IGI USA"), a WOS of IGI Belgium and a step-down WOS of IGI India; and (ii) acquisition of AGL Holdco Inc. (and indirect acquisition of American Gemological Laboratories LLC ("AGL")) from Christopher P Smith, Helene Smith ("Sellers"), we wish to inform you of the following pursuant to Regulation 30(7) of the Listing Regulations that we have been informed on February 14, 2026 that IGI USA has completed the acquisition of 100% of the shareholding of AGL Holdco Inc. from Christopher P Smith, Helene Smith ("Sellers") and indirect acquisition of AGL.

Accordingly,

- i. AGL Holdco Inc. has become WOS of IGI USA and step down WOS of IGI Belgium and IGI India with effect from February 10, 2026; and
- ii. American Gemological Laboratories, LLC, WOS of AGL Holdco has become a step-down WOS of IGI USA, IGI Belgium and IGI India with effect from February 10, 2026.
