Pursuant to the Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 and in continuation of our earlier intimations as submitted to the Exchange with respect to the Petition filed under Section 9 of the Insolvency and Bankruptcy Code, 2016 by M/s Ujaas Energy Limited ("Operational Creditor") against M/s Sayaji Hotels (Indore) Limited ("Corporate Debtor" / "the Company") before the Hon'ble National Company Law Tribunal, Indore Bench ("NCLT") and pursuant to the Settlement agreement between both the parties, M/s Ujaas Energy Limited has filed an application for withdrawal of the case on February 27, 2026.
