**Sub: Outcome of the meeting of Board of Directors held on 9<sup>th</sup> June 2026**

**Re: Qualified institutions placement of equity shares of face value ₹ 1 each (the “Equity Shares”) by Motisons Jewellers Limited (the “Company”) under the provisions of Chapter VI of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “SEBI ICDR Regulations”), and Sections 42 and 62(1)(c) of the Companies Act, 2013, as amended, including the rules made thereunder (the “Issue”).**

We wish to inform you that pursuant to the approval accorded by the Board of Directors of the Company (the “Board”), at its Meeting held on March 06, 2026, and Special Resolution passed by the members of the Company through Postal Ballot held on April 25, 2026, the Board of Directors, at its meeting held today, i.e., 9th June 2026 inter-alia, considered and approved the following :

- a) authorization of the opening of the Issue on 9th June 2026;
- b) Approving the Floor Price of ₹ 11.58 per Equity Share for the Issue in accordance with Regulation 176 of the SEBI ICDR Regulations; and
- c) Approving and adopting the preliminary placement document together with application form dated 9th June 2026 to be sent to qualified institutional buyers inviting bids and for the purpose of receiving filled in application forms along with application amounts for the subscription of Equity Shares in connection with the Issue; and

We further wish to inform you that the Board of Directors has fixed the ‘Relevant Date’ for the purpose of the Issue, in terms of Regulation 171 of the SEBI ICDR Regulations, as 9<sup>th</sup> June 2026 and accordingly the floor price in respect of the aforesaid Issue is calculated based on the pricing formula as prescribed under Regulation 176(1) of the SEBI ICDR Regulations is ₹ 11.58 per Equity Share. Pursuant to Regulation 176(1) of the SEBI ICDR Regulations, the Company may at its discretion offer a discount of not more than 5% on the Floor Price so calculated for the Issue.

In relation to the Issue, we will file the Preliminary Placement Document with BSE Limited and NSE Limited on 9<sup>th</sup> June 2026.
