Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that we wish to inform you that, the Committee of Directors ("For Preferential Issue") of the Mufin Green Finance Limited ("the Company") in their meeting held on today i.e. March 4, 2026, has approved the allotment of 2,49,30,765 (Two Crore Forty Nine Lakh Thirty Thousand Seven Hundred Sixty Five) fully paid-up equity shares of face value Rs. 1/- each at an issue price of Rs. 98/- per share (including a premium of Rs. 97/-), and 76,53,061 warrants at an issue price of Rs. 98/- per shares as per details enclosed in **Annexure I**.

Post allotment, the paid-up equity share capital of the Company stands increased from Rs. 17,32,31,423/- (comprising 17,32,31,423 equity shares of Rs. 1/- each) to Rs. 19,81,62,188/- (comprising 19,81,62,188 equity shares of Rs. 1/- each). The equity shares so allotted shall rank pari-passu in all respects with the existing equity shares of the Company.
