Duty demand of INR 3,15,40,918/- U/s 28(4) of the Customs Act, 1962, b. Interest U/s 28AA of Customs Act 1962 (not quantified), c. Redemption fine of INR 3,00,00,000/- U/s 125 of Customs Act, 1962 d. Penalty of INR 3,15,40,918/- U/s 114A of the Customs Act 1962, along with interest U/s 28AA of Customs Act 1962 (not quantified).

(d) details of the violation(s)/contravention(s) committed or alleged to be committed	A premise-based audit was conducted by the Commissionerate in May 2024, with the final audit report issued in June 2024. Pursuant to the audit, Show Cause Notice (SCN) No. 678/2024 was issued in December 2024, to which the Company had submitted a detailed reply in March 2025. Further, personal hearings were conducted by the Commissioner of Customs in November 2025 and the Company had given suitable explanation against the audit findings. Subsequently, this Order-in-Original dated December 12, 2025, was passed by the Commissionerate alleging the non-compliance of Section 46 of the Customs Act, 1962, in relation to the filing of Bills of Entry and the obligation to truthfully declare all particulars therein.
(e) impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	a. Duty demand of INR 3,15,40,918/- b. Interest (not quantified), c. Redemption fine of INR 3,00,00,000/- d. Penalty of INR 3,15,40,918/- along with interest (not quantified). The Company intends to contest the duty demanded, interest, redemption fine, and penalty before the Customs, Excise, and Service Tax Appellate Tribunal within the stipulated timeline.
