Further to our above-referred intimation, we wish to inform you that Hintastica Private Limited (“HPL”), a 50:50 Joint Venture of Hindware Home Innovation Limited and Atlantic Societe Francaise De Developpement Thermique, France, has completed the sale of its certain identified manufacturing assets to Ariston Water Heating Products India Private Limited (“Ariston”), including land, buildings, plant, machinery, and equipment at Green Industrial Park, Polleppally Village, Jadcherla Mandal, Mehaboob Nagar, Telangana, India, pursuant to the Asset Sale Agreement dated 17 October, 2025.. The consideration has been revised from INR 116 crore to INR 115 crore based on a post-signing commercial review in accordance with the terms of the Asset Sale Agreement and other ancillary documents.
