Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we are pleased to inform that the Company has secured a new Work Order from the **Government of Maharashtra, State Health Assurance Society (SHAS)** (Integrated Ayushman Bharat–Pradhan Mantri Jan Arogya Yojana & Mahatma Jyotirao Phule Jan Arogya Yojana) ("Authority").

The Work Order relates to **printing of PVC Ayushman Cards** for the following **six districts of Maharashtra State: Akola, Washim, Yavatmal, Amravati, Buldhana and Wardha.**

The total value of this order is ₹ 26.13 Lakhs (inclusive of GST), with a stipulated completion timeline of 180 days.
