Highway Infrastructure Limited Secures Largest-Ever Single Work Contract Worth Rs. 328.77 Crores; Order Book Exceeds Rs. 1,000 Crores

Madhya Pradesh, India 10 December, 2025: Highway Infrastructure (“HIL”), an integrated infrastructure development and management company with strong capabilities across Toll Operations, EPC Infrastructure and Real estate, is pleased to announce the **receipt of Letter of Award (LOA) from the National Highways Authority of India (NHAI) for operation at Kaza Fee Plaza on Chilakaluripet Vijayawada section of NH-16 from Km 355.000 to Km 437.500 (Length-82.5km) in the state of Andhra Pradesh.**

The LOA, **valued at Rs. 328.77 crores**, marks the largest-ever single work contract awarded to the Company. The mandate **covers engagement for user fee collection and operations management for one year**, including upkeep and maintenance of adjacent toilet blocks and consumables, on NH-16 a key north-south connectivity corridor.

This achievement marks a significant inflection point in HIL’s growth trajectory, with the company’s **order book growing by ~103% from Rs. 531 crores in March 2025 to over Rs. 1,000 crores as on date**, thereby enhancing revenue visibility and supporting its growth strategy.

Order Book Position

The order book as on 10th November 2025 stood at Rs. 750 crores and with the addition of current work order the Company’s total consolidated order book now stands at **Rs. 1,078 crores** as on date, comprising Rs. 577 crores in EPC projects and Rs. 502 crores in toll projects. The EPC order book grew by 38% since March 2025, while the Tollways collection order book has grown by 340% compared to March 2025.

Speaking on the development, Mr. Arun Kumar Jain, Managing Director, Highway Infrastructure Limited said: “Securing the Company’s largest-ever single work contract in toll operations is a landmark achievement that underscores our ability to handle high-value projects at scale. Crossing the Rs. 1,000 crores order book milestone positions us for accelerated growth and stronger financial performance. Our robust order pipeline ensures sustained revenue visibility, and successful execution of larger projects will further enhance our eligibility for even bigger contracts, unlocking new opportunities. With challenges behind us, we are entering a phase of strong, profitable growth and are committed to delivering strong growth ahead.”
