Dear Sir/Madam,

This is in continuation of our earlier disclosures mentioned above, regarding Provisional Attachment Order ("**PAO**") dt. March 31, 2025 against Dalmia Cement (Bharat) Limited ("**DCBL**"), a material wholly owned subsidiary of the Company, by the Enforcement Directorate ("**ED**"), Hyderabad, provisionally attaching land parcels of DCBL. The PAO was confirmed by the Adjudicating Authority, PMLA on September 22, 2025.

Further on appeal, the PMLA Tribunal vide its final order dated March 9, 2026 had partially allowed the appeal reducing the Proceeds of Crime ("**PoC**") to Rs.92.52 crs and also ruled that as far as application of the Company for substitution is concerned, the ED may decide the same.

Without prejudice to its right and contention, DCBL made an application to ED along with a bank guarantee of Rs.92.52 crs. The ED vide its order dated April 21, 2026 has ordered release of entire attached land parcels.

Accordingly, as on date the alleged POC has been reduced to from Rs.793.34 cr to Rs.92.52 crs. DCBL is in the process of filing an appeal against the impugned order w.r.t. the alleged POC of Rs. 92.52 Cr.

The details as required under Regulation 30 of the Listing Regulations read with SEBI circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13,2023 are provided in the Annexure hereto.
