Subject: Corporate Announcement on Order Booking and Update

We are pleased to share business updates for Fabtech Technologies Cleanrooms Ltd. for the month ended **November 30, 2025** along with progress on our ongoing strategic growth initiatives.

- 1) During November 2025, the Company secured consolidated orders worth ₹45.27 crore, led by the Renewable Energy sector (₹25.08 crore), followed by Pharma (₹10.75 crore), Education (₹9.13 crore), and Data Centres (₹0.31 crore). From a business vertical standpoint, ₹35.34 crore was contributed by Cleanroom Partitions and ₹9.93 crore by HVAC Systems.
- 2) As of November 30, 2025, our consolidated order book stands at (₹200.29 crore), comprising Renewable Energy (₹95.41 crore), Pharma (₹75.12 crore), Semiconductors (₹10.90 crore), Data Centres (₹7.47 crore), and Others (₹11.39 crore.)
- 3) Orders under active consideration total ₹756.21 crore, with major opportunities in Renewable Energy (₹346.86 crore), Pharma (₹189.30 crore), Semiconductors (₹150.79 crore), Data Centres (₹40.00 crore), and Others (₹29.26 crore).
- 4) During the month, our subsidiary, Kelvin Air Conditioning & Ventilation Systems Pvt. Ltd., bagged a significant order amounting to (₹ 9.13 Crore) for a project being executed in the Academic Science Block, IIT Bombay, marking an important milestone in the Higher Education sector and strengthening our presence in institutional infrastructure projects. The Company also continued to witness strong traction in the Renewable Energy sector during November 2025, reinforcing our strategic focus on high-growth industries and our turnkey capabilities in delivering integrated cleanroom and HVAC solutions for advanced manufacturing facilities.
