The binding term sheet has been executed for the operation of a brownfield hotel property located at Tirupati Homes, Mahaveer Bag Colony, Opp. Anushree Hotel, Indore Road, Ujjain, Madhya Pradesh. The proposed property comprises 55 rooms across two interconnected buildings, along with requisite back-of-house and utility infrastructure in line with the Click Hotel brand standards, as detailed in Annexure A.

This proposed property aligns with the Company's strategy to expand its presence in Tier-II pilgrimage and business destinations and is expected to further strengthen its asset-light operating portfolio.
