# OpenAI to amend Pentagon deal

Deal looked 'sloppy', says CEO Altman

**OPENAI CHIEF EXECUTIVE Officer (CEO) Sam Altman said that the company's rush to forge a deal with the Defence Department — following a clash between the Pentagon and rival Anthropic — looked "opportunistic and sloppy."**

In a post on the X social media service, Altman said his company was working with the department to "make some additions in our agreement to make our principles very clear."

That includes ensuring that AI isn't used for domestic surveillance of Americans and that intelligence agencies like the National Security Agency can't rely on OpenAI services.

The remarks follow an announcement late Friday that Altman had reached an agreement to let the Pentagon deploy OpenAI's artificial intelligence (AI) models in its classified network.

showdown with Anthropic, which had demanded its technology not be used for mass surveillance of Americans or autonomous weapons deployment. The rare admission from OpenAI's chief emerged days after Anthropic's main app topped Apple's download charts, reflecting a surge of support for the company during its feud with the Pentagon.

Altman and Anthropic's Dario Amodei have clashed repeatedly in the past



over seemingly divergent approaches to AI development.

Their competition intensified this year with a series of advances by Anthropic — most notably the growing popularity of its Claude Code suite, which surpassed OpenAI's Codex in market adoption.

But in its latest post, OpenAI made a point of saying it disagreed with the Defence Department's decision to blacklist its arch-foe.

The startup added it will host an all-hands meeting this week to address its own employees' questions.

Anthropic earlier stipulated that its products not be used to surveil Americans or make fully autonomous weapons, and said on Friday "no amount of intimidation or punishment from the Department of War (DoW) will change our position." OpenAI announced its own pact with the Pentagon mere hours after Anthropic's blacklisting.

OpenAI emphasised that it will add language to the Pentagon pact to ensure its own platform won't be used for domestic surveillance.

"There are many things the technology just isn't ready for, and many areas we don't yet understand the trade-offs required for safety," Altman said.

He said his company was hasty in making its deal with the Pentagon. "We shouldn't have rushed to get this out on Friday," he said. "The issues are super complex, and demand clear communication."

He described it as a "good learning experience" as the San Francisco-based firm faces high-stakes decisions in the future.

Earlier, OpenAI said it had reached an agreement with the US DoW to deploy its models in their classified network.

Two of OpenAI's most important safety principles are prohibitions on domestic mass surveillance and human responsibility for the use of force, including for autonomous weapon systems, Altman said on X.

"The DoW agrees with these principles, reflects them in law and policy, and we put them into our agreement," he said.

"We also will build technical safeguards to ensure our models behave as they should, which the DoW also wanted."

# Pahalgam attack: GoPro cam activated in China, says NIA

**AN NIA COURT** in Jammu has issued a Letter Rogatory (letter of request) to the competent judicial authority in China for assistance in finding the supply chain and end-user details of an electronic device linked to the probe into last year's terror attack in Pahalgam.

The move came in response to an application filed by NIA Deputy Inspector General Sandeep Choudhary under BNS section 112, which empowers Indian courts to issue a 'Letter of Request' to authorities in foreign countries regarding evidence that may be outside India.

Terrorists had on April 22, 2025, killed 25 tourists and a local guide in South Kashmir's Pahalgam. Referring to the seizure of various material and

electronic devices connected with the conspiracy and execution of the terrorist attack, the NIA application said that one such crucial electronic device was a GoPro camera, which is relevant for establishing pre-attack reconnaissance, movement and operational preparation of the terrorist module involved in the Pahalgam attack.

"A lawful notice under the Bharatiya Nagarik Suraksha Sanhita was issued to the manufacturer GoPro B V, seeking details regarding the supply chain and activation of the said device," the NIA said, adding that the manufacturer in its official response informed that the "said camera was supplied to AE Group International Limited, a distributor based in the People's Republic of China; and the camera was activated on 30.01.2024 at Dongguan, People's Republic of China."

Pointing out that the activation, initial use and commercial trail of the said device lie within the territorial jurisdiction of the People's Republic of China, the NIA filed the application before the court as the "information necessary to trace the purchaser, end-user, and associated technical records can only be obtained through judicial assistance of the Chinese authorities."

"Since India and China are not signatories to any mutual treaty... on the subject, in such an eventuality, assistance as requested can be sought under the United Nations Convention against Transnational Organized Crime (UNTOC) as both the nations have ratified the UNTOC," observed NIA judge Prem Sagar, adding that the home ministry also has given its concurrence for the issuance of the Letter Rogatory to China for seeking legal assistance.

# Govt seals ₹5,083-cr missile upgrade deal

**THE DEFENCE MINISTRY** on Tuesday sealed contracts worth ₹5,083 crore for the procurement of six Advanced Light Helicopters (ALH) and surface-to-air missiles. While the ALH Mk-II helicopters are being procured for the Indian Coast Guard, the Shtil missiles will be deployed onboard the Indian Navy's warships. "The contract for ALH Mk-II along with operational role equipment, an engineering support package, and performance-based logistics support, valued at ₹2,901 crore, has been inked with Hindustan Aeronautics," the ministry said. It said these

twin-engine helicopters incorporate state-of-the-art features superior to the currently operated airborne platforms and are capable of undertaking a wide spectrum of maritime security missions from shore-based airfields as well as from ships at sea. "The induction will significantly enhance the Indian Coast Guard's capability for fulfilling the duties of safety and protection of artificial islands, offshore installations and protection of fishermen and marine environment," the ministry said.

The contract for the procurement of surface-to-air vertical

launch - Shtil missiles and associated missile holding frames, valued at ₹2,182 crore, has been signed with Russia's JSC Rosoboronexport.

The acquisition is intended to enhance the air defence capabilities of frontline warships against a wide spectrum of aerial threats, the ministry said. "The system will reinforce the layered air defence architecture onboard the platforms of the Indian Navy by providing rapid-reaction, all-weather engagement capability and improved survivability in contested maritime environments," it said. # Cricketing feast on the cards with bevy of match winners

**THE BAIL-TRIMMING NIP-BACKER** of Matt Henry and the dipping leg-cutter of Lungi Ngidi; the devilish bouncer of Kagiso Rabada and the brutish toe-crusher of Lockie Ferguson; the switch-hit of Finn Allen and the mid-wicket shovel of Quinton de Kock. The New Zealand versus South Africa semifinal promises a cricketing feast, with varied layers of artful deception. Apart from a mystery spinner, the two teams have everything that is valued in the format.

**Power-hitters:** New Zealand can rattle out the names of Glenn Phillips, Finn Allen and Tim Seifert; South Africa could match them man-for-man with Quinton de Kock, Ryan Rickelton and David Miller.

**Cultured strikers:** Aiden Markram, in blazing form,

slashes down Rachin Ravindra, striving for his best touch.

**Spin quotient:** Mitchell Santner and Keshav Maharaj cancel each other out.

**All-round artillery:** Marco Jansen, Cole McCoinchie and Jimmy Neesham would battle it out, as would others such as Phillips and Corbin Bosch.

**Genuine quick** Henry and Rabada would raise the pulse.

South Africa are undefeated in the tournament and meted out a thrashing to India. New Zealand have lost twice, to South Africa and England.

Henry's nip-backer is a thing of beauty. Delivered with an upright seam, the wrists snapping a wee bit at release and the ball decking back subtly rather than substantially to hit the stumps. Pathum Nissanka's hollow eyes after a Henry brute uprooted his stumps capture the story. The Kiwi pacer possesses a scrambled-seam ball

that wobbles and an off-cutter that cuts back sharply into the torso. It's not only the reduction of pace that batsmen fear, but the bounce too. New Zealand, though, would be praying that he returns from home after the paternity break.

But what he has, Ngidi and Rabada possess too. Ngidi has two gorgeous cutters — one comes in, the other goes away — that ran India's batters ragged. Rabada's basket of variations has often missed the perfect landing, but he can turn up in clutch matches and produce a spell for the ages.

South Africa has a better-grooved pace core, with Jansen and Bosch completing the lineup. Jansen's lift and Bosch's accurate yorkers have discomfited batters. Their opponents, though, have deeper spin gears, so much so they drew 17 overs from tweekers against Sri Lanka.

# Hiring in India up 12% in Feb amid AI push, IT recovery: Naukri report

**INDIA'S WHITE-COLLAR JOB** market recorded a 12% year-on-year growth in February, amid increasing AI adoptions and a recovery in the IT sector, a report said on Tuesday.

White-collar job market posted its strongest February performance in recent years, with the Naukri JobSpeak Index reaching 3,233 points - up 12% from 2,890 points in February 2025.

The month-on-month acceleration came in at 23%, noticeably sharper than the 13-16% range typically seen between the two months, the report based on Naukri JobSpeak Index added.

The IT sector posted over 6% year-on-year growth in hiring in February 2026. Freshers' hiring in the sector also grew by a healthy 8%.

India-based multinational IT companies were the primary driver, recording a 55% hiring surge, the report said. Within the IT sector, it said that AI/ML hiring rose 40%.

The report further said that freshers' hiring grew 17% annually, while the demand for roles in the ₹20 lakh-per-annum band rose 23%.

Non-IT sectors continued to anchor the hiring momentum, with insurance leading at 28%, followed by BPO/ITES (22%), real estate (19%), hospitality/travel (15%) and retail (14%).
